The following is a summary of discussion items from the first quarter IAC meeting held on February 26, 2019.

EIM management and the IAC discussed the Risk Managers Information Meeting. Overall the meeting and the speakers were well received. EIM received positive feedback from the attendees.

The IAC task force committee chairs discussed the following:

- Cyber Liability – New Deloitte report on cyber attacks, CA passage of a law allowing consumers to sue a company when there is a cyber breach even if no damages. A case between Mondelez and Zurich involving the definition of “act of war.”
- Pollution – Focusing on regulatory initiatives relating to pollution. A PHMSA data update will be given at the June meeting
- Emerging Risk – Driverless car and battery storage will be the main topics in 2019. AI will also become part of the Emerging Task Force.
